Non-Discrimination Policy: No student or applicant for enrollment as a student at Forest Grove Community School shall be discriminated against in any educational program or activity on the basis of race, religion, sex, sexual orientation, ethnicity, national origin, disability, income level, proficiency in the English language or athletic ability. **Enrollment of any student receiving special education services pursuant to an Individual Education Plan (IEP) must be approved by the student's IEP team.**

Enrollment Lottery: If there are more applicants than spaces available, state law requires that admission be determined by lottery. Students who submit enrollment forms during open enrollment (Jan. 15-April 1) make up the lottery pool. The lottery will take place at 4:00 p.m. Mon., April 9, 2012 at FGCS. The lottery is open to the public, but parents and students are not required to attend. Parents/guardians will be notified by April 15, 2012 by email or by phone whether their students have a space for 2012-13 or whether they have been placed on a waiting list. **Please do not call the school office to inquire about lottery results.** Students applying after April 1, 2012, may be admitted on a space available basis but will not be part of the initial lottery.

As a courtesy to our staff and students on wait lists, please notify FGCS immediately if your plans to enroll change.
