**Note:** If your child is currently being served by special education services through an Individualized Education Plan (IEP), the IEP team may meet to determine how your child's needs can be met at FGCS. In accordance with procedural safeguards for special education, a school district must serve resident children with disabilities attending public charter schools located in the district in the same manner as the school district serves children with disabilities in other district schools.

**Non-Discrimination Policy:** No student or applicant for enrollment as a student at Forest Grove Community School shall be discriminated against in any educational program or activity on the basis of race, religion, sex, sexual orientation, ethnicity, national origin, disability, income level, proficiency in the English language or athletic ability.

**Enrollment Lottery:** If there are more applicants than spaces available, state law requires that admission be determined by lottery. Students who submit enrollment forms during open enrollment (Jan. 15-April 3) make up the lottery pool. The lottery will take place at 3:45 p.m. Thurs., April 6, 2017 at FGCS. The lottery is open to the public, but you are not required to attend. Parents/guardians will be notified by April 15, 2017 by email or by phone whether their students have a space for 2017-18 or whether they have been placed on a waiting list. **Please do not call the school office to inquire about lottery results.** Students applying after April 3, 2017 may be admitted on a space available basis but *will not* be part of the initial lottery. **Priority enrollment for siblings of current students applies during the open enrollment period Jan. 15-April 3 only.** Sibling applications submitted after April 3 will be handled on the same basis as non-sibling applications.
